GAR Part 145 Validation Conditions Supplement

Issue of Validation - 145.7

The Guernsey Aviation Requirements (GAR) 145.5 (a) validation issued to your organisation by the Guernsey Director of Civil Aviation (DCA) is subject to the following conditions:

- a) the accepted host approval identified in GAR 145.5 (a) remains valid, and
- b) the organisation does not exceed the approval ratings and scope of the host approval, and
- c) the organisation remains in compliance with GAR Part 145 Subparts A and C and the relevant requirements of GAR Part 43, and
- d) the additional conditions defined in this Validation Conditions Supplement.

Maintenance Organisation Exposition (MOE) / Repair Station Manual (RSM) - 145.9

For initial and continued validation, you must supply a copy of your MOE/RSM compliant with GAR 145.5 (a), including future amendments. It must be supplied in the English language in accordance with GAR 145.9 (a).

Privileges of validation holder & approved locations – 145.11

The capability, scope and approved locations are limited to those detailed in your GAR 145.5 (a) host approval MOE/RSM and GAR 145.11.

Duration of validation - 145.13

The DCA validation is valid:

- a) for 24 months from date of issue provided the host approval remains valid, or,
- b) until revoked, or suspended by the DCA; if revoked or suspended the validation certificate must be returned to 2-REG.

Notification of ceasing maintenance - 145.15

Should the organisation cease to offer maintenance services to Guernsey registered aircraft you must notify 2-REG in writing within 30 days.

Renewal of validation – 145.17

The organisation shall make an application to 2-REG for the renewal of the validation not less than 30 days before it expires.

Licences and type ratings (authorisation holders) – 145.19

Aircraft maintenance engineers working under the authorisation system of their host approval per GAR 145.5 (a), and holding a licence issued by an authority listed in GAR Part 21.25(a)(1) are not required to hold a licence issued under GAR Part 66.

Safety Management Systems (SMS)

You must comply with your SMS as specified in your SMS manual or host approval MOE/RSM as applicable.

Continued Compliance, privileges and limitations 145.51, 145.53

The Nominated Quality / Compliance Monitoring Manager of the GAR 145.5 (a) host approval must ensure:

- a) **MOE/RSM and validation conditions - 145.51:** A copy of the host MOE/RSM and associated procedures including these GAR Part 145 Option 1 validation conditions are made available at each approved location.
- b) **Training 145.107:** Certifying and non-certifying personnel are trained and made aware of these validation conditions. Certifying staff shall receive initial and continuation training as specified in GAR 145.107 (a) & (c).
- c) **Design changes - 21 Subparts C and M:** All design changes (modifications and repairs) to Guernsey registered aircraft will be carried out to the requirements of GAR Part 21 Subparts C and M respectively; in accordance with approved maintenance data relevant to the product, part or appliance.
- d) **Release to Service 145.11 & 43.105:** A Certificate of Release to Service (CRS) will only be issued for a Guernsey registered aircraft whose type and model is listed on the relevant schedule or capability list of the host approval. Each CRS will be in accordance with GAR Part 43 Subpart C and/or GAR 145.11(5)(i) and will use the appropriate Tech log/Work pack, the required statement of release to service 43.105 (a), and your validation number, e.g. 2-REG.145.[XXX].
- e) **Independent Inspections 43.111:** Independent inspections must be performed as detailed in GAR 43.111.
- f) **Mandatory Occurrence Reporting - 13.51:** Mandatory Occurrence Reporting must comply with GAR 13. Link: [Occurrence Reporting](#)

Maintenance Control Manual 145.57

Each holder of a maintenance organisation validation shall:

- a) hold copies of any applicable Maintenance Control Manual (MCM) or equivalent; and
- b) establish procedures for ensuring current issues are available to personnel at all locations where they need access to such documentation.

Aircraft and aircraft parts 145.59

All components installed on Guernsey registered aircraft will be supported by a suitable release certificate in accordance with GAR Part 21 Subpart K & maintained in accordance with GAR 145.59.

When maintaining a component for its 'own aircraft' (as defined in GAR 145.59), the internal component release procedure as described in your host approval MOE/RSM section must be used.

Communications with 2-REG

The responsible person for communicating with 2-REG within the approved maintenance organisation is the Nominated Quality / Compliance Monitoring Manager.

Access

The DCA and the DCA's Designated Civil Aviation Inspectors are to be granted access to the organisation on request.
